**NEW BUSINESS: Docket 2020-02 Preliminary Hearing** for a proposed (1) Lot Subdivision and Indianapolis Blvd. Zoning Overlay District Development Plan. Representing the petitioner, Carmen Arvia /DVG Team, Inc., 1155 Troutwine Rd., Crown Point, IN for a proposed Gas Station and related convenient store at the Northeast corner of Indianapolis Blvd. and Hart Rd. commonly known as 9337 Indianapolis Blvd.

Mr. Arvia of DVG Team said they were there to request the Development of a 2.4-acre parcel at the corner of Indianapolis Blvd and Hart Rd. on the northeast corner. He said the petitioner would like to build an eight-pump island fuel station with a 3600 sq. ft. convenience store. He continued that they have come to the Study Sessions over the last few months to resolve some of the concerns regarding traffic and design issues and believes they came to an agreement with those concerns with the Plan Commission. He is requesting to be on the agenda for the Plan Commission Public Hearing Meeting of October 21, 2020 for a proposed (1) Lot Subdivision & ultimate approval of the overlay district site plan.

Commissioner Kissee commented that he went to some of the other gas stations the petitioners own and he feels the stations are very clean, organized, fresh looking and the convenience store is very well-kept and clean as well. Commissioner Zemen agreed.

Commissioner Martini motioned to grant the Public Hearing. Commissioner Grzymski seconded and it passed with a unanimous vote of 7 - 0.
