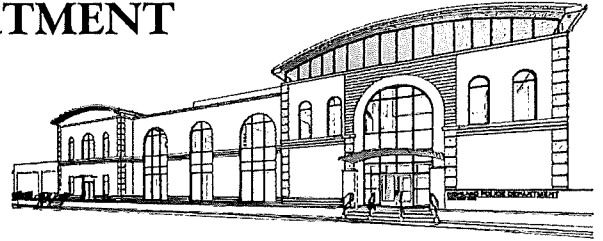

The Highland Middle School National Junior Honor Society dropped off cookies.

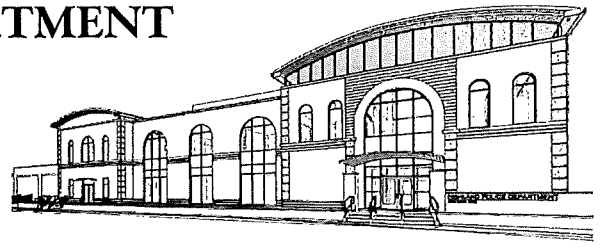
