Twilight Parade ( July $3^{\text {rd }}$ Line up 4:30-5:30 Parade kicks off @6:30pm) Kristen/DeAnna/Christine/Chris/Elmo Several entries with Candy Throwing violations: Veterans (throwing candy from truck) BulkMatic (Using an air gun to shoot items from the vehicle) Political entry throwing beads from car, UAW (Alcohol and throwing candy- warned twice), Alberts (Alcohol), Several political candidates complaining about the wait and expressed they feel they should go first continued complaints to several volunteers after their concern had been addressed. Dance teams stopping to perform, Texas Corral characters creating huge gap, Nikki Moulesong car entry (Throwing Candy), Stracks (Early Line up) Dress Divas (Vehicles did not arrive together) Indiana Right To Life (Complaint received about signage being too graphic for family event).
