Minutes: Request for a motion to approve minutes of the last meeting held October 19, 2023.

Old Business:

a. <u>NWI Tree Planting Consortium</u>: A Memorandum of Understanding with Delta Institute appeared on the agenda of the 10/23/23 Town Council meeting and was unanimously approved. The next Consortium remote meeting has been rescheduled to be held Tuesday, 11/21/23 at 1 PM for which Board members have received a Microsoft Teams invitation. - b. <u>Tree Pruning Workshop</u>: On 11/6/23, the Tree Planting Consortium and CommuniTree Program hosted a Tree Pruning Workshop led by Arborist Jerome Delbridge, Tree-Centric Solutions of Indianapolis. The program consisted of an educational lecture, then hands-on pruning of trees at Deep River Lake County Park in Hobert. Underkofler gave Jim Colias some excellent handouts for distribution to board members, including a "Tree Board Handbook", Arbor Day Foundation. It's a comprehensive guide to help board members understand their role and how they can best contribute to the board. Underkofler asked Delbridge to send a template for a Request for Proposals to retain a qualified arborist consultant firm to undertake the town's pruning services. The RFP would contain specifications for a scope of services, a schedule for a multi-year project by geographical area, budget by year and method of compensation. Underkofler wrote he is hoping Highland pruning work could start in Fall 2024 after leaves have fallen.
- c. <u>2024 Arbor Day Event</u>: Mary Ann Blunt volunteered to identify an elementary school to be scheduled for an Arbor Day Event and to secure pledges from the principal and maintenance staff to water and care for a tree. She made an inquiry to Amy Harrington, Principal Johnston School. The Indiana DNR Division of Forestry's Community and Urban Forestry program is sponsoring an Arbor Day Poster contest for 5th grade students and teachers next year. The theme for 2024 is Oak Trees: Superheroes of the Forest. The student who creates the winning poster will receive a gift card, a book for continuing their exploration of trees, and an Indiana native tree planting at their school. The winning student's teacher will receive a kit of educational materials to support their class's further engagement with Indiana trees, forests, and forestry, as well as a full scholarship to the Natural Resources Teacher Institute. DNR is also looking for volunteers to help with judging. If you are interested, email Racheal Stenger at rstenger@dnr.IN.gov.

 a. <u>2024 Indiana Arborist Association Conference</u>: This annual conference will be held Tue Jan 23rd 2024, 8:00 am - Thu -Jan 25th 2024, 3:00 pm EST. Indiana Tree City USA communities will receive a 50% Discount off of Urban Forestry Day on January 23rd, 2024. The discount code is UF2024. Ron Jackowski and Underkofler participated in this conference in 2023 and found it quite interesting. b. <u>Update Board Action Plan</u>: The Board may review, change and update its 2023 Action Plan.

- Secure 1-2 speakers per year for educational sessions on pertinent topics. Assigned to Colias. The first community presentation was held at Highland Library 3/29/23; another was scheduled 9/27/23 but canceled due to insufficient registrations.
- 6. From the approximately 13 Jackowski nursery maple trees, secure utility locates and replace dead trees at the Merkley and Warren Schools, in parkways and street medians; plant new trees in yard locations requested by Elizabeth Herrejon and Bernie Zemen. Assigned to a weekend crew consisting of Jackowski, Underkofler, Roberts, Zemen and Colias with help from Highland Neighbors for Sustainability. 11 trees completed by 4/2/23; 2 remaining were planted 10/8/23.
- Decide on events in which we will participate to acquaint the community of our endeavors, identify homeowner planting sites, and recruit volunteers: Assigned to Roback as Lead. Park Pride Day completed 4/22/23; Thursday Market completed 6/22/23.
- 8. Update Unapproved / Approved Species List with photos of recommended tree species. Assigned to Jackowski Completed 10/19/23.
- 9. Maintain community partnerships with Chamber of Commerce & Highland Businesses. Assigned to Roberts as Lead.

- 10. Apply for available grants and keep a running tally of trees that we procure. Assigned to Underkofler.
