Larry Kondrat, Highland, questioned why the advertisement aggregate for the hearing was not \$5,107,410.83 versus the breakdown of \$5,057,410.83 for the American Rescue Plan Fund and \$50,000 for the Redevelopment Capital Fund to be used for Façade Improvement. ORDINANCE No. 1792.1578-E of the TOWN of HIGHLAND, INDIANA

AN ORDINANCE to AMEND ORDINANCE No. 1578, AN ORDINANCE TO ESTABLISH THE WAGE and SALARY RATES of the ELECTED OFFICERS, the NON-ELECTED OFFICERS, and the EMPLOYEES of the TOWN of HIGHLAND, INDIANA, PARTICULARLY REGARDING CHANGE TO THE STAFFING AUTHORITY and JOB TITLES in the METROPOLITAN POLICE DEPARTMENT.

WHEREAS, Title 36, Article 1 Chapter 4 of the Indiana Code confers certain general corporate powers on the several units of government in Indiana;

WHEREAS, Section fifteen of that chapter specifically provides that a unit of government may fix the level of compensation of its officers and employees; and

WHEREAS, I.C. 36-5-3-2 further provides in pertinent part that the town legislative body shall provide reasonable compensation for the other town officers and employees;

WHEREAS, I.C. 36-5-3-2(b), still further provides that the Town Legislative body shall, by ordinance fix the compensation of its own members and the Town Clerk-Treasurer;

WHEREAS, I.C. 36-5-3-2(c) still further provides that the compensation of an elected town officer may not be changed in the year for which it is fixed, nor may it be reduced below the amount fixed for the previous year; and

WHEREAS, The Town Council of the Town of Highland, as the town legislative body, now desires to amend the ordinance that was adopted to fix the compensation of its elected officers, appointed officers and employees of the Town for the year 2024;

NOW, THEREFORE, BE IT HEREBY ORDAINED by the Town Council of the Town of Highland, Lake County, Indiana, as follows:

Section 1. That Section 10 (E)(5) of Ordinance No. 1578 be amended by repealing Section 10(E)(5) of that Ordinance in its entirety and replacing with the following section, which shall be numbered as Section 10(E)(5) and read as follows:

Section 10. That subject to the provisions of this ordinance, the salary and wages for the non-elected officers and employees of the Town of Highland are hereby fixed for its **Metropolitan Police Department** as follows:

(E) Other Police Officers and Assignments.

(5) The following represent <u>assignments</u> in the Metropolitan Police Department for which the following salaries are authorized. Persons so assigned shall be paid the greater of the assigned person's pay attached to person's actual service rank or grade, or the pay associated with the listed assignments depicted as follows:

If we average them out and pretend that the assessed value of each unit is \$300,000, the maximum tax dollars drawn out each year on each would be \$3,000 for each unit. If you take the 32 units and multiply by \$3,000, you will come up \$96,000 annually in increment. At the last meeting, the Redevelopment Director said the Town had applied for a \$4.5mm state grant, called the Redi Grant and if they got the grant, they would give it to the developer of the town home. \$4.5mm is not a small amount. If you collect \$96,000 a year in property taxes or increment, in order to break even, it will take forty-six (46) year. Forty-six (46) years to break even. Has the Council told the developer to jump in the lake?
