Business from the floor: Barrington Parker, of 9410 Erie, with his neighbor Sonny of 9404 Erie, were present with a power point presentation to discuss a water issue he has on his property with the runoff of his neighbor's property onto his and issues he has getting a quote from businesses to do any kind of landscaping. Mr. Gracia stated we don't normally allow power points but since we have it we will allow it this one time. Mr. Parker showed how his property has been affected by the overflow of the neighbors run off and the easement. He stated a contractor did landscaping for neighbors at the time if the project and Mr. Parker has reached out to the contractor and many other contractors and can't get any of them to give him a quote for landscaping. He just wants some resolution. It was explained to Mr. Parker that the town cannot force a contractor to give him a quote. Sonny stated the project that was done was a great help and is working great, he was one of the neighbors who had the contractor do the extra work on his property. Mr. Snyder explained the project that was done years ago to help with flooding issues in the area which is working as intended and some neighbors had taken extra steps at that time to help their properties with water drainage at their own expense. Mr. Parker stated he paid for the extra drainage and he would like his money back. Mr. Knesek stated Mr. Parker did not pay the town for that work and that work was done through a contractor the homeowners hired. Mr. Parker stated he knows what he wants to do to tie into the pipes and he wants to do the job himself. Mr. Snyder explained he would need to contact a qualified contractor to come up with plans to show the elevations and how they're going to get there and present it to the town to be approved. This and the work would be paid for at Mr. Parkers expense. Mr. Parker asked if the town would come out and do that. Mr. Knesek again stated the property of Mr. Parker is able to tie into the pipes if plans are submitted and approved. However, a contractor has to come up with plans and it would be paid for at Mr. Parkers expense. Mr. Snyder again explained what needs to be done and presented. Mr. Parker stated "It sounds like I need a professional to do this." Mr. Tweedle stated "Yes. A professional will know what needs to be done and present. And it would all be at your expense. The town won't do any work or pay for it." Mr. Parker stated he understood and was grateful for the commissioner's time and explanations. Commissioner Jones told Mr. Parker he could contact the building department for a list of contractors registered with the town. Mr. Parker and Sonny then left the meeting.
