The motion passed. Ordinance 1804 was passed and adopted upon the signature of the municipal executive

ORDINANCE No. 1804 of the TOWN of HIGHLAND, INDIANA

AN ORDINANCE AMENDING CHAPTER 9.05 OF THE HIGHLAND MUNICIPAL CODE ENTITLED FIRE DEPARTMENT

WHEREAS, In consequence of the execution of its public safety powers, set forth in IC 36-1-4, and IC 36-8, the Town of Highland through its Fire Department, the Town Provides Fire prevention, suppression, life and limb and other emergency public safety services; and

WHEREAS, I.C. 36-1-3-4 et sequitur, provides that a unit of town government possesses all powers granted it by statute and all other powers necessary or desirable in the conduct of its affairs, even though not granted by statute; and

WHEREAS, It has been determined that several provisions of Chapter 9.05 need to be modified and enhanced to reflect the current job description for the Fire Chief; and

WHEREAS, The Town Council has determined the municipal code requires amendment in order to the current job description of the Fire Chief.

NOW, THEREFORE, BE IT HEREBY ORDAINED BY the Town Council of the Town of Highland, Lake County, Indiana, as follows:

Section 1. That Chapter 9.05; Section 9.05.03(B) of the Highland Code of Ordinances is hereby amended by repealing it in its entirety and replacing which shall read as follows:

- (B) The fire chief shall be a full-time position subject to the following:
 - (1) The Fire Chief shall be appointed by and serve at the pleasure of the Town Council upon receiving a recommendation from the Personnel Committee of the Highland Firemen's Association. The Town Council reserves the right to reject any recommendation from the Personnel Committee and direct that another recommendation, be made.
 - (2) The Fire Chief shall have a minimum of ten (10) years' experience in the Fire Service, with an extensive background in; fire operations, fire cause and origin, fire inspection, firefighting training and emergency management operations. (An extensive background is defined as a combination of actual experience,

education and training that can be demonstrated by action and educational documents received and evaluated by the Personnel Committee).

- (3) The Fire Chief shall have a minimum of five (5) years as a Lieutenant, Captain, Operations Chief or Chief.
- (4) The Fire Chief shall enter into a contract with the town with regard to the services to be performed and the full-time Fire Chief position shall be a PERF covered position.
- (5) The Fire Chief's position shall also include all of the duties of the fire inspector, the Chief Fire Code Official as defined in section 103.1-103.4.1 of the Indiana Fire Code with the authority listed in section 104.1-104.11.3 of the 2006 International Fire Code, the Fire/Rescue/EMS training administrator, the Town Disaster and EMS Management Director and the EMS services and contracts administrator. The Fire Chief shall be paid in the amount and manner set forth in the most recently adopted wage and salary ordinance as may be amended from time to time for the performance of the duties associated with the position.

Section 2. That Chapter 9.05; Section 9.05.07(3) of the Highland Code of Ordinances is hereby amended by repealing it in its entirety and replacing which shall read as follows:

(3) Machines, Tools, Equipment, Software.

Funds to support these additional appropriations in the Municipal Cumulative Streat Fund shall be supported by miscellaneous revenue, unreserved unobligated fund balance on deposit to the credit of the fund.

Taxpayers appearing at such meeting shall have a right to be heard thereon. The additional appropriations, as finally made, will be filed with the Department of Local Government Finance, for its review. The Department of Local Government Finance and I make a written determination of the sufficiency of funds within fifteen days of receipt of a certified copy of the action taken.

- 11. Controlled Event Permit. Action regarding permission to conduct a festival of the Main Street Bureau on a public way submitted by it, October 10, 2024. This is a controlled event under Chapter 5.25. Section §5.25.020(B) requires action by the Town Council in an open regular or special session. The Council will also need to fix the amount of liability insurance, pursuant to §5.25.020 (D). Pursuant to that section, the Town Council has previously directed that the applicant procures liability insurance for the event which names the Town of Highland as an additional insured in the amount of One million dollars (\$1,000,000) and provide a certificate or proof of this insurance before the event and those businesses serving alcohol Insurance policy.
- (b) Request from Main Street Bureau seeking permission for its event of October 29, 2024, as a controlled event. They are having no outside vendors so there will be no need for picnic tables or garbage receptacles. Traffic cones will be required at Fourth

& Highway and Kennedy and Highway.

When the applicant is the municipality, through its executive departments, its administrative bodies, or agencies, no formal application is required provided that a request shall be filed in sufficient time to permit the town council to act in a regular or special meeting in advance of the event.

The town council must act in a regular or special meeting upon the application or request, where it may, in its discretion, issue such permit and likewise, in its discretion, may refuse the issuance of a permit.

Councilor Robertson moved to approve the request from the Main Street Bureau to conduct a controlled event, where alcohol would be dispenses on Highway Avenue, a public way, from 4th Street west to Kennedy Avenue on October 29, 2024, from 4 o'clock p.m. to 9 o'clock p.m. as part of the Restaurant Crawl. Councilor Black seconded.

Discussion:

Councilor Black wanted to know if this restaurant crawl replaces the restaurant crawl that was canceled because of the weather. He was advised yes.

Councilor Turich wanted to know with the last crawl being canceled, did the Town get the insurance payment back and could it be applied to this restaurant crawl?

Councilor Robertson said it wasn't the Town that had to pay for the additional insurance but the restaurants who wanted to participate in the crawl. He further explained, that the restaurants participating didn't have to pay for additional insurance to have the Town of Highland named as a additional insured.

Councilor Turich asked if there aren't activities planned on the street, then why close the street?

Redevelopment Director Becerra said that it is the hope of the Main Street Bureau, that parents will bring their children in costume and trick or treat to the various businesses on Highway Avenue.

Councilor Black didn't think it was wise to have kids in costumes walking Highway Avenue, even with their parents, while people are carrying alcohol outside of the establishments and walking Highway Avenue. He didn't think the two make for a good mix.

Councilor Scheeringa commented on the event in Whiting which is similar to the upcoming restaurant crawl. He said it is a huge success in Whiting.

Upon a roll call vote, there were four (4) affirmatives and 1 negative, with Councilors Georgeff, Turich, Robertson and Scheeringa voting in the affirmative and Councilor Black voting in the negative. The motion passed. The controlled event permit was granted.

Councilor Turich acknowledged Building Commissioner Ken Mika who said the Plan Commission will be meeting this Wednesday, if Attorney Reed is finished with the findings of fact from the petition they had last month. He said the BZA will be meeting next Wednesday. The only item on the agenda is a use variance request for a person who wants to perform tattoos. He said from the Building Department, Cardinal Campus is moving along as they finished the underground utility installation and should be pouring the floors next week. They hope to have the steel delivered within the next two (2) weeks. He said if anyone has driven by the soon to be Dunkin Donuts on Kennedy Avenue, the former Brewfest, the owner of the property has made great strides in remodeling the property. He said a hydrostatic test was performed on the sprinkler system for the Osborne Storage unit project. The main building is pretty much complete. He said the street improvements on Osborne should begin within the next two (2) weeks. He then extended his appreciation to Officer Orth for his efforts in assisting code enforcement. He said a conscientious effort to team up and deal with three (3) car repair businesses in Town that have literally turned into junkyards.

Councilor Turich asked about the status of the backyard on the house of Jewett? Mr. Mika said if Attorney Reed had been there tonight he would have asked him. Unfortunately, once it is turned over to the Attorney, it is really out of their hands.

Councilor Turich then acknowledged Park Superintendent Alex Brown, who said the pickleball courts at meadows are complete and people were using them on Sunday. He said the surfacing is done on the tennis courts in Brantwood. All that is left is to line the courts and install the nets. He said the contractor is breaking ground for the Pop Warner storage facility behind Lincoln Center. The storage facility will save them a lot of money because in the winter they had to rent storage space to house the equipment. He said the Park Department will use ½ of the building for storage. Next Monday, soccer, baseball and softball will be done and the contractor will then begin making modifications to the concession stands to make them ADA compliant. The contractor hopes to be done by Thanksgiving. He said this Thursday is the Community Band Concert in Monbeck Auditorium. The concert is free and the band members really work hard. This weekend is the garage sale in the field house. He said the event is sold out. He said there is a bus trip going to Boston. It consists primarily of seniors. He said the bus trip is also completely sold out. Last Friday was the 2nd annual night bike ride. It was very well attended and the weather cooperated. He wanted to pass along to the VIPS and Police Department a thank you for all they do for that event.

Councilor Turich asked about a winter festival. He said Alyce from the recreation staff is working on that. Alex said he didn't know the exact date but it is around the second weekend in December.

Councilor Scheeringa asked Alex about basketball sign-ups. Alex said the sign-ups continue through November 1. He said the numbers are high for the boys and low for the girls.

He said leaf pick-up has started which means if you have branches to be picked-up, you need to call the public works garage and get put on the list. He said there is no set schedule but when time is available. He said the sewer remediation project is fast approaching the conclusion of phase one. The contractor is heading up Duluth. He said all of the pipe is to be installed by the end of the month. The contractor is working on re-installing the water lines on Parrish Avenue. He said they have the HCCE's on Saturday and another coming up this Thursday. He thanked all who came to the Fire Department Open House as it was a great success. He particularly thanked the wives and girlfriends and everyone who helped to make it such a successful event. The fire fighters have been doing a lot of fire prevention work this month in the schools and some pre-schools. He said they have one tomorrow at OLG.

Councilor Turich asked about the status of the grant for the new radios. Chief Pipta said he hasn't heard anything and in talking with another Fire Chief, that Fire Chief is starting to get nervous.

Councilor Scheeringa then acknowledged IT Director Ed Dabrowski who thanked the Council for approving the fund transfer. He said he is working on establishing Wi-Fi for the downtown lighting project. He emphasized the Wi-Fi won't be for public use. It will only be operational at night when the lights are on. He is working with Tom Brown on reviewing our cyber insurance policy. He is hoping that there isn't a large increase. He said we might want to look at other companies. He said he reached out to several sources who had no problem with the audio from tonight's meeting. Councilor Scheeringa said he brought it up on his phone and had no problem. He reminded everyone that Facebook is a free service. People might complain but it is free.

Comments from Visitors or Residents:

Mike Stone, Highland, who said he lives on Prairie and is concerned with the speeding on 45th and Prairie. He said he sees hundreds of cars going down those streets daily, speeding. It is a posted 20 mph and he's fine with 30 mph but these cars are going closer to 40 or 60 mph. He was wondering if anything could be done about it, like the installation of speed bumps? He was told that the Town doesn't like to install speed bumps but he's read where other communities are installing them to slow down speeding and they appear to be working. He also asked whose responsible for raised sidewalks. He said as he is walking, he see many a raised sidewalk. Some higher than others and the higher ones causes problems for senior citizens walking with a cane or walker.

Public Works Director Knesek gave Mr. Stone his card and asked Mr. Stone to give him a call and he's take a look at them. He reminded Mr. Stone that it is the responsibility of the property owner to correct.

Mike Kokot, Highland also commented about speeding. He pass out a flyer from Munster and asked the Council to review. He said Highland is a retirement town. Maybe the Council could propose a referendum to citizens on how they feel about speed bumps or hiring more police officers and would they be willing to fund such projects. He feels the

police are not doing enough to slow down speeders. He says the police have to do something outside the box. He then asked about the overgrown trees and grass and the overall run down appearance of Schuyler Square. Mr. Mika responded that they have been working with the owner, who is a retired doctor living in California. The Town is pursuing the problem through property maintenance.

Mr. Kokot then brought up the separation in the asphalt between lanes on Indianapolis Boulevard by Meiers and Discount Tire. He said if a motorcycle got their tire in there, they would most likely crash.

Public Works Knesek said that situation has been brought to the attention of INDOT who are sending out a maintenance engineer to review the problem.




A message from Town Council President

"I feel the need...the need for speed"

Lately in Munster, it seems like everyone wants to be like Tom Cruise. From speeding down side streets, to trying to beat the red light, it feels like our local streets have become more like the Indy 500.

Your council has been working together to try many different ways to bring drivers back in line by installing speed bumps, closing roads, emphasizing school and pedestrian crossings and using portable radar signs. Part of the reason for hiring more police officers was to help patrol areas where speeding seems to be a major issue.



Nationwide, speeding fatalities reached a 14 year high in 2021 and made up almost 1/3 of all traffic fatalities. Whether you're 16 or 60, distracted driving is the main reason people are unaware that they may be speeding. The biggest distraction is the cell phone, followed closely by reaching for food or a dropped item. We all need to recognize speed triggers, including tailgaing or trying to catch up with the car in front of you. Prevention starts with YOU!

The Town of Munster is looking into many alternate ways to slow down cars, but your help is the best prevention. You can avoid driving too fast by checking your speedometer often, being aware of STOP signs and other traffic signs, concentrating on the task at hand and avoiding distractions.




An older friend of mine was known for her "lead foot". She was out doing errands and was stopped by an officer, receiving a ticket. A few blocks later, in a different neighborhood, she was caught speeding again. She tried to get out officer that "she had just gotten a ticket from the other officer just 10 minutes ago!" Don't be this citizen.

When you reduce your speed, you are not only a safer driver but you can save on your insurance by not having any tickets. To help with this, allow extra driving time by leaving a bit earlier. Speeding costs you more than just the price of a ticket, which can run from \$200 for 1-10 miles over the limit, up to \$300 for 21 miles over the limit. In addition to this, there are court costs and lost work time.

Speeding costs, you extra gas and replacing tires and brakes sooner. Check online for Apps that monitor your speed and help you find the easiest way to get to your destination.

Lydia Shotts, Highland complimented the work of the contractor on Main Street. The contractor worked at night to complete the roadwork. She said it looks beautiful. They did a great job. She also said the tracks were repaired at the CN crossing. She said she saw a flyer on the upcoming restaurant crawl but there was no menu. She said she talked with Dan Botich after the last Redevelopment meeting regarding the south Kennedy Avenue project and he advised that the property in question is not in a wetland. She wanted to know if there is a wetland delineation report?

Councilor Georgeff said that before any building takes place the Army Corp of Engineers can request such a report but he wasn't sure the Town would see such a report.

Ken Mika said the whole process would start with the Plan Commission and because of talk of wetlands the Plan Commission could request such a report. At this point in time, nothing has come before the Plan Commission.

Councilor Turich said there is no project before the Town, it is all talk.

Public Works Knesek said with the way laws have been changed regarding wetlands, he said he would be surprised if anything is considered wetlands anymore.

Jeff Rosignol, Highland said he came before the Council sometime in January and raised questions about the Town's SBOA audit. I met with the Clerk-Treasurer about two (2) weeks ago as a follow-up and I was extremely pleased to know that all of the findings were corrected and submitted to the SBOA and approved by the SBOA.

Carol Parker, Highland, a member of the HCCE wanted to thank Fire Chief Pipta for saving the day for the Backyard BBQ when the festival experienced an electrical issue with a Nipsco transformer and Chief Pipta reached out to NIPSCO who came out an fixed the problem. She also reminded people of the upcoming Trunk & Treat, this Saturday at Main Square. It is from 10:00 o'clock a.m. to noon. She said there will be a DJ, some food, picnic tables and plenty of games for the kids. She said the HCCE has started putting out signs around Town for the Trunk or Treat. She also handed out the invitation to the Council that was handed out to the Highland businesses asking them to participate in a Christmas Tree decorating contest. The businesses will design their own tree and awards will be given through the QR codes. The idea is to decorate the Town while at the same time getting people to stop in an shop in those businesses. She then asked about any idea of storage space where the HCCE could store their materials. She asked Park Director Brown if the Parks had any storage space. She said they would pay for it through their profits. She wanted everyone to know that all of these things we're are purchasing are from their profits and not from the Town. Alex Brown said they are sharing the cost with Pop Warner and he was sure space could be found in the new building which is 40' x 80'.

Larry Kondrat, Highland was concerned that if the Town did pass the DORA, downtown Highland would be turned into a giant frat party. He was confused how the Council wanted people walking around downtown drinking beer. He said he didn't hear any

complaints, so why the need for a DORA. He then said to Councilor Robertson, no offense Alex but you are heading up this project and you being an owner of an establishment would directly benefit by it. To him, it seemed seven (7) kinds of wrong.

Councilor Robertson asked Mr. Kondrat if he had specific questions he could answer.

Mr. Kondrat said he was wondering how an elected official is allowed to put together a plan that directly benefits his business. He said Councilor Robertson should recluse himself and not participate any longer.

Councilor Robertson said he didn't think it would specifically benefit his business since he has already stated about redrawing the map and removing his business. He said the common misnomer about DORA's is that the rules are less lenient but DORA's actually add more rules to our downtown area as it pertains to alcoholic refreshments.

Mr. Kondrat said he read the Ordinance as prepared by Councilor Robertson and there is no mention of the requirements that a DORA cannot be closer than 250' from the front door of a church or school. If it is, then you have to receive permission from that school or church. You have 4 churches and 2 schools that fall within that rule as you have drawn the DORA map.

Councilor Robertson said it is not specifically spelled out because it is part of the application process. In order to be granted, you have to have your application approved and if your establishment is within the 250' boundary, you will have to get permission from the church or school.

Councilor Black said in fairness to Councilor Robertson, he is acting in his capacity as the liaison to the Downtown Association.

Mr. Kondrat said he understands that but has there been a cry from the people of Highland to be able to walk around downtown or in the parks and drink.

Councilor Robertson said to Mr. Kondrat that as he drafts the final version, your comments won't fall of deaf ears. You raised some good points, many of these points he raised himself. Keep in mind, the Ordinance was conceptual and we'll have more discussions. Nothing is permanent.

Councilor Turich told the Council that he would be happy to take the lead on it.

Councilor Scheeringa asked if there were any other comments. Hearing none, he closed comments from the public and brought it back to the Council. He then asked for a motion to pay claims.
