The Thirtieth Town Council of the Town of Highland, Lake County, Indiana met in its regular plenary session on Monday, January 27, 2025 at 6:30 O'clock P.M. in the regular place, the Highland Municipal Building, 3333 Ridge Road, Highland, Indiana.

*This meeting was convened as an in person meeting and lived streamed to the Town of Highland Facebook. Facebook permits the public to observe and record the proceedings but allows no interaction between and among the Town Council and members of the public. The public is able to participate in person. Councilor Georgeff, Councilor Doug Turich, Councilor Alex Robertson, Councilor Tom Black and Councilor Philip Scheeringa all participated in person.

Pursuant to HMC Section 2.05.130(A)(2), the Town Council considered and reviewed the agenda in an informal proceeding in the plenary meeting room before the president called the meeting to order.

The Town Council President Philip Scheeringa presided over the meeting. The Town Clerk-Treasurer, Mark Herak, was present to memorialize the proceedings. The meeting was opened with Councilor George Georgeff reciting the Pledge of Allegiance to the Flag of the United States of America and offering a prayer.

Roll Call: Present on roll call were Councilors George Georgeff, Alex Robertson, Thomas Black, Philip Scheeringa were present. Clerk-Treasurer, Mark Herak was also present. A quorum was attained.

Additional Officials Present: Alex Brown, CPRP, Superintendent of Parks and Recreation; Metropolitan Police Chief Ralph Potesta; Redevelopment Director Maria Becerra; Mike Pipta, Fire Chief; Ed Dabrowski, Director of Information Technology, Kenneth J. Comments from the Public or Visitors:

Katrina Daniel, Highland, commented regarding Ordinance No. 1813 and the events that occurred at the January 13, 2025 study session. While discussing a woman's compensation, the discussion of family planning came up. I'm not an employment law expert, but that comment, whether intentional or not could be considered discrimination, putting Highland at risk for a lawsuit. She wasn't sure as Attorney Reed wasn't there but he would probably say the same thing. Last year, in Hendricks County, west of Indianapolis, \$300,000 was paid out from taxpayer's money for a discrimination case. She said she is an HR Professional and a good HR Manager can proactively advise everyone about HR issues. The Town should think about hiring an HR Professional.

Carol Parker, Highland, said the HCCE is very happy to see the Parks more engaged and taking on more responsibility, as the HCCE put in over 120 to 130 hours individually in 2024 and remember there were only five (5) of us. She asked that what the HCCE has already set in motion, like the amusement rides, fireworks, appreciation lunches for the workers of the Town, bands that had been consulted and who verbally committed, the wristbands that were given to winners from the dance contests and especially contracts that are already in place, would be honored by the Park Department. It is important that the Town's word to people means something. As things are moving forward, realizing that some members of the HCCE who initiated those things might not or might be on the new HCCE Commission, Ordinance No. 1813 states that input from the HCCE will be considered. I hope this does take place, especially when it comes to the 4th of July and the BBQ Festival. Those events bring in the most revenue but they also exert the most amount of man hours and work hours. The Parks, as they become more engaged, will have the advantage of having paid employees to do the work but the working knowledge is with the members of the HCCE.

Jeff Rosignol, Highland, wanted to share his views of keeping the liaison position in house and saving a lot of money versus going out and hiring someone from the outside. He heard numbers for a total compensation package from \$100,000 to \$150,000. He thought the decision to keep it in house was fantastic. He complimented Kathy Camp-Burke, who handled the food vendors last year but decided not to reapply this year. He said she not only handled the food vendors for the 4th of July but she also ran the Republican hot dog booth. The main she did was to make sure there wasn't a duplication of products, which the vendors liked. She really did a phenomenal job.

ORDINANCE No. 1813 of the TOWN of HIGHLAND, INDIANA

AN ORDINANCE TO AMEND CHAPTERS 3.05 AND 11.15 OF THE HIGHLAND MUNICIPAL CODE TO ALTER THE OVERSIGHT AND APPOINTING AUTHORITY RELATED TO THE COMMUNITY EVENTS COMMISSION AND REPEALING CONFLICTING ORDINANCES, ALL PURSUANT to IC 36-1-3 ET SEQ. AND OTHER RELEVANT STATUTES.

- WHEREAS, The Town of Highland is a local unit of general government governed by a Town Council, which is both the fiscal and legislative body of the Town;
 - Whereas, The Town of Highland, is a municipality located in Lake County which operates as a Town under the laws of Indiana; and,
- WHEREAS, IC 36-1-3-2 and IC 36-1-3-6(b)(1) confer upon all local units the powers that they need for the effective operation of government as to local affairs and prescribe the manner and form of enactment for any such exercise of power; and
- Whereas, IC 36-1-3-6 (b)(1) prescribes that any such exercise of power shall be
- authorized through enactment of an ordinance passed by the legislative

body; and

- **Whereas,** The Town of Highland, is a Municipal Government which may pass and codify ordinances for the operation of the government, all pursuant to IC 36-1-4 and IC 36-1-5; and,
- WHEREAS, The Town Council as the governing body for the municipality, may establish, aid, maintain, and operate recreation facilities, cultural, historical programs, pursuant to its general culture and recreation powers conferred in IC 36-10-2;
- WHEREAS, The Town Council has enacted certain ordinances regarding the Community Events Commission, a Commission of the unit organized pursuant to IC 36-10-2 and IC 36-1-3 et seq.; and,
- WHEREAS, The Town Council recognizes that volunteers and volunteer organizations are essential to the success of special events and community gatherings; and

- WHEREAS, The Town Council desires to further perfect the culture and recreation services of the municipality, currently delivered by a Community Events Commission, organized pursuant to IC 36-10-2 and IC 36-1-3; and
- WHEREAS, The members of the Town Council, the Park and Recreation Board and the Community Events Commission have discussed ways and means to further perfect the culture and recreation services of the municipality; and
- WHEREAS, The members of the Town Council, the Park and Recreation Board and the Community Events Commission have discussed transferring the oversight and appointing authority of the Community Events Commission to the Park and Recreation Board, under provisions of IC 36-10-3-17; and

Councilor Turich then acknowledged Park Superintendent Alex Brown, who said the new light poles are up at Sankowski Field. The actual lights will be installed by April in time for the Highland's JV's game and Highland's girls softball. He said it looks like there will be a break in the weather and the park crew will be able to take the Christmas Decorations down at Main Square. He said the cold weather made the ice at Meadows pond really good. There were a lot of skaters taking advantage of the good ice this past weekend.

• Councilor Alex Robertson: Fire Department Liaison • Redevelopment Commission Member • Public Works Liaison • Liaison to Main Street Bureau • Liaison to the Tree Board • Liaison to the Highland Neighbor for Sustainability.

Council Robertson began by thanking the HCCE for all the hard work they put in over the years, growing and making the festivals successful. He acknowledged Public Works Director Mark Knesek who said with the sub-zero weather, the Town is getting bombarded with water main breaks. He said if anyone has rave, and the many notifications about water main breaks, people are calling in to ask if there really are that many water main breaks. He tells them that its no mistake. With cold temperatures, causing Lake Michigan water to get super cold causing stress cracks in the water mains as the water is pumped through. He said they had a strange one today, called in by resident Larry Kondrat. He said somehow the water from the break made its way into a resident's garage and the water was coming up through the floor. Upon investigation, it was the resident's service line which ran underneath the garage, which is never a good thing. The public works crew worked on that for five (5) hours. They needed a jackhammer to break the frost to get to the water main. He commented that they had six (6) water main breaks last week. He described one that happened last week, which wasn't the Towns. It occurred behind the buildings of Highland Grove. The water hydrant valve bonnet blew off and as water was flowing out of the hydrant, the water made its way to a Nipsco ground transformer, which caused a super dangerous situation. Thankfully, the water just flowed into the retention pond after that. The Highland Fire Department was called out as the breaker boxes were vibrating and smoking. That continued until Nipsco killed the power. The mall contracted with Grimmer Construction to do to repairs. Back in the nineties, for some reason the valve companies decided to get some Chinese steel bolts and save a little bit of money. Over time, these bolts began to corrode and break. Highland had the same bolts used in the subdivision behind Meijer and were experiencing the same problem. The Water Department took a proactive approach and dug up every valve in the subdivision and replaced all the bolts on the flanges. The Town replaced all of the bolts with stainless steel. He said with the minimum amount of snow fall so far this year, the salt dome is full and he hasn't had to go out and purchase anymore salt.

Councilor Georgeff asked Mr. Knesek when we will be going out for bids on the solid waste contract?

Mr. Knesek said the bid packages were already sent out and are due this Friday. The bid opening will take place at the Public Works Garage. He said three (3) companies pick up


the bid package. He hopes that all will submit proposals but his concern they won't. Most don't have the equipment to cover the Town in one (1) day as required. He gave the example of Homewood Disposal which has Munster's contract. Munster allows them to do the Town in five (5) days.

Councilor Georgeff asked Councilor Black that since he is on the Solid Waste Management Board, if he could use his expertise and review the proposals. Councilor Black said he would.

Councilor Robertson then acknowledged Fire Chief Mike Pipa who said that since the last plenary meeting, they had 24 calls, including an auto aid with Schererville on a structure fire a week ago Sunday. He said they responded to a box alarm in New Chicago which was a fatal fire. Once they got out there, they were told they weren't needed. For the box alarms, their territory is everything north of US 30, with Schererville being the quadrant to the west. He said Truck 2 is back in service and parked in South Station. South Station is running now at full capacity with a truck and engine. He also commented on the water break behind Highland Grove that Public Works Knesek commented on earlier in the meeting. As Mark had said, all the water from the hydrant was flowing into the Nipsco ground transformer. He said he was the 1st to respond to a fire call at Best Buy. He said every other light in Best Buy was flickering on and off in the store. Store clerks were calling him into the back by the electrical panels as they were all chattering. When he went back into the store, he smelled smoke. He then went outside figuring it has to be a power issue. When he went outside and back, he saw the Nipsco ground transformer covered in water and ice forming. He immediately called out Nipsco. At that point the fire fighters safely evacuated everyone from Lynn's Furniture, all the way to Ashley Furniture. While evacuating, the fire pump in Lynn's Furniture kicked on and quickly filled the room with smoke as it burned up. That started to set off fire alarms in other stores. At that point, one of his officers felt it was best that we upgraded it to a structure fire, immediately calling out departments from Schererville, Munster and Griffith. The next day, he went back out to the scene. He said the only damage was in the fire sprinkling room.

Councilor Scheeringa began by thanking everyone who helped him as the 73^{rd} Town Council President. He said it was a real pleasure and he learned a lot. He said it can be cumbersome at times and you a lot of papers to sign.

He then acknowledged IT Director Ed Dabrowski, who said just a brief report just to piggyback on something that Chief Potesta mentioned about the new Animal Warden. If anybody wants to reach out to the Animal Warden, you can reach him at animalwarden@highland.in.gov. He said he is finishing the phone upgrade in the police department. He is moving the police department's phone system onto the Town's. Previously, the police department had their own stand alone system. The upgrade should save the Town roughly \$15,000 a year in savings. He is also looking at some email and software options that could save the Town another \$4,000 a year. He said he finally got the last zone to work so he was able to turn off the Christmas theme downtown (red & white).

<u>Safe Street for All.</u> A Consultant made a presentation today with recommendations. These recommendations would be to make improvements to intersections that have a high accident record or fatalities. With this Plan the Town is eligible to apply for an Implementation Plan for federal dollars to implement the short- and long-term recommendations, 1st quarter of this year. These federal grants can be as high as 7 million dollars, the funds will sun set 2027.

The Town will continue with the process of updating the Master Plan this year.

We continue to seek input from Highland Residents on their visions for the Town for the next 10-20

Several applications have been received for the Commercial Grant funding for this year.

Main Street will have their first meeting February 6th at 6:15. The is a proposal to change the monthly meeting to the first Thursday of every month.

That concluded comments from the Council and President Georgeff then turned it over to comments from visitor's or residents, reminding them to limit their comments to 2 minutes.

Comments from Visitors or Residents:

Larry Kondrat, Highland began by congratulating Councilor Georgeff on his election as Town Council President. He then began talking about a wheel tax which will be discussed in the study session immediately following the plenary meeting. He was advised that not much discussion will take place until it is sure the bill will be adopted. Larry said the Council really needs to consider it because that's where we get our road money. I was driving down Martha Street today and that's like a goat path. It is the bumpiest road I've seen in Highland in a long time. He said he has never seen so many potholes that need fixing. The last council considered a road tax but didn't adopt one. If the State requires a road tax, you need to make sure the State keeps the current funding, in addition to the road tax. If the State cuts back funding for roads because of a road tax, you should end the road tax. The State did the same with Education. They sold the lottery on additional revenues to fund education. After the lottery was in place, they eliminated the school funding already in place and replaced it with only the money from the lottery. If a road tax is implemented, the Council should keep the current funding level and add the road tax to the pool, so more roads can get paved, maybe write into the ordinance that the current percentage of funding for roads without a wheel will be maintained after the road tax is implemented. Also, I would like to see a sunset provision that expires at the end of each Council's term. Make the new or incoming Council vote on the wheel tax.

Public Works Director Knesek responded to the suggestion of a sunset provision. If the bill is passed, the Town will have to implement a road tax otherwise we'll lose funding for the CCMG. A sunset provision would essentially eliminate Highland from receiving funds.

Jeff Rosignol, Highland, said he was here roughly six (6) months ago, maybe longer and he spoke to the Council and Attorney Reed regarding a problem he was having with a short term rental across the street from his house. He realized that Attorney Reed wasn't present tonight but he was inquiring if anything was done? He continued, there is a short-term rental policy in place in the Town of Highland, prohibiting Airbnb's in the Town of Highland.

Building Commissioner said they are allowed but they must be owner occupied. In this particular case, the owner of the house lives in California.

Mr. Rosignol said his concern is that the policy is not be enforced. You have an absentee owner, living in California, who rents out his house as an Airbnb and nothing is done about. He advertises in ads. My concern is that as I see strange cars or vans coming and going from the house. How do we know if its not be used as a location for the trafficking of kids or housing migrants. He said we all know what happens to migrants, Highland arrests them. They send them to County where there processed and then transport to Chicago, where Chicago lets them free in a matter of minutes. He referenced a situation in Logansport and other parts of the state. He said the owner seems to be following the State Statute but not the Town's.

Mr. Mika said he feels Mr. Rosignol's frustration as he is experiencing the same frustration with Attorney Reed. Nothing has been done. He said he asked Attorney Reed to file an injunction against the owner but nothing happens.

Mr. Rosignol said he has talked with John on numerous times and he has said he was working on it but nothing.

The Council advised Mr. Rosignol that the next time it happens to reach out to Building Commissioner Mika.

Councilor Georgeff asked if there were any other comments. Hearing none, he closed comments from the public and brought it back to the Council. He then asked for a motion to pay claims.

There being no further comments from visitors or residents, Councilor Scheeringa moved to allow the vendors accounts payable vouchers as filed on the pending accounts payable docket, covering the period January 15, 2025 through January 27, 2025, . The accounts payable vouchers for the vendor docket were allowed, payments allowed in advance were ratified, the payroll dockets listed not inclusive of the Fire Department Quarterly were ratified and for all remaining invoices, the Clerk-Treasurer was authorized to make payment.
