The Thirtieth Town Council of the Town of Highland, Lake County, Indiana met in a special study session on **Monday**, **February 17**, **2025**, immediately at the adjournment of the February 17, 2025 Plenary Meeting (6:45 o'clock P.M)., in the regular place, the Highland Municipal Building, 3333 Ridge Road, Highland, Indiana.

*This meeting was convened as an in person meeting and lived streamed to the Town of Highland Facebook. Facebook permits the public to observe and record the proceedings but allows no interaction between and among the Town Council and members of the public. The public is able to participate in person. All Councilors were simultaneously seen and heard. Councilor Georgeff, Councilor Turich, Councilor Robertson, Councilor Black, all participated in person. Councilor Philip Scheeringa was absent.

2. *Interview with Jim Norris.* The Town Council indicated that Mr. Norris was being considered for appointment to the Highland Metropolitan Police Commission.

Mr. Norris said on a personal note, with his son being a police officer and him being a big advocate of public safety, the Police Commission was his preference but would do whatever he could do to help out from the police standpoint.

Councilor Scheeringa asked Mr. Norris does he know many of the officers. Mr. Norris said yes.

Councilor Scheeringa advised Mr. Norris that the Police Commission seems to tick off some of the officers with the decisions they make and you have to realize that you will inevitable tick off friends of your son and even your friends.

Mr. Norris said he dealt with that in the mills. He would put buddies aside as he is a rules kind of guy. They had to follow the rules as do police officers which why we have rules.

Councilor Turich asked Mr. Norris what kind of strategies would he like to see implemented if he was selected to enhance community relations in our Town? Additionally, he asked how would Mr. Norris measure the success of those initiatives?

Mr. Norris said he really didn't have any strategies but once serving and got familiar with the commission and familiar with things happening in Town, he would be able to implement some good ideas and go forward.

Councilor Turich asked Mr. Norris if he had any ideas or opportunities that he's identified?

Mr. Norris said he couldn't.

The Town Council President thanked Mr. Norris for attending.

It is the appointing authority for the department, appointing list civilian and sworn members, "subject to the qualifications for employment determined by the board and approved by the legislative body". It also names the Chief, "subject to the qualifications for employment determined by the board and approved by the legislative body" as well. Once hired, decisions to promote and demote are the province of the Town Board of Metropolitan Police Commissioners, as by law, it is the safety board for the purposes of discipline. Further, the Town Board of Metropolitan Police Commissioners is charged with forming and promulgating general rules and regulations for the government and discipline of the police department and may make special and general orders to the department through the police chief, who is defined at law as the executive head of the department (IC 36-8-9-4(d).) No appointee may hold an elective or appointed political office while serving on the bureau.

Appointing Authority shall give sole consideration to individuals who are knowledgeable about or employed as executives or managers in following businesses: Hotel, Motel, Restaurant, Travel, Transportation, Convention, Trade Show, Riverboal, banking, real estate, and construction. The Lake County Convention and Visitor Bureau is comprised of fifteen (15) members, eight of whom are appointed by the Town Council President or Mayor of the eight largest municipalities in the county; two of whom are appointed by the legislative bodies of the two largest municipalities in the county; two of whom are appointed by the Lake County Council; two of whom are appointed by the Lake County Council; two of whom are appointed by the Lake County Council; two of whom are appointed by the Lake County Commissioners and one of whom is appointed by the Indiana Lieutenant Governor.

☐Redevelopment Commission

Member must be 18 years old & reside in unit

The Redevelopment Commission is comprised of five persons, three of whom are appointed by the Town Council President and two of whom are appointed by the Town Council. The Redevelop Commission promotes economic development but also the renovation of older development, Under Indiana law, the Redevelopment Commission has the duty to (1) investigate, study, and survey areas needing redevelopment within the corporate boundaries of the Town; (2) investigate, study, determine, and, to the extent possible, combat the causes of areas needing redelopment; 3) promote the use of land in the manner that best serves the interests of the town and its residents; and (4) select and acquire the areas needing redevelopment to be redeveloped under IC 36-7-14 et seq.

☐ Economic Development Commission

The Highland Economic Development Commission consists of three members, two of whom nominated by either the County Council or the Town Council and all are appointed by the Town Council President. Unless filing an unexpired term, terms are four-years

The economic development commission shall investigate, study, and survey the need for additional job opportunities, industrial diversification, water services, and pollution control facilities in the town, and shall recommend action to improve or promote job opportunities, industrial diversification, water services, and availability of pollution control facilities in the town.

As part of the foregoing, an economic development commission makes determinations related to economic development target areas, and issue special types of bonds for economic development.

☐ Community Events Commission

No person shall be appointed as voting member of the Commission who has not attained the age of 18 years, who is not a resident of Highland or who holds any other town office by appointment

The Community Events Commission is established to advise and assist with the planning and execution of special events within the Town of Highland. The purposes of the Commission are: (1) To coordinate the annual celebration of the 4th of July festivities (Independence Day) including, but not limited to: a festival, parade and fireworks; (2) To coordinate a Christmas Parade; (3) To coordinate Memorial Day and Veteran's Day ceremonies; (4) To initiate plans for the Town of Highland's Centennial Event in 2010; and (5) To assist with other special events the Commission determines will promote good will in the Town of Highland, including, but not limited to an annual 18th Century Historical Reenactment, Seasonal Festivals, Beer Gardens, Block Parties, Parades, Arts & Craft Shows and Itinerant Restaurants:

☐ Highland Main Street Bureau Board of Directors

Membership criteria and structure have yet to be fixed by ordinance.

This organization, the details of which are still being formulated, will be dedicated to promoting growth, development, and stability in the Highland downtown and to utilize public/private partnerships to achieve these goals. Members will strive to effectively and efficiently develop steps to restore, revitalize and promote the downtown of Highland. The four tenants of the Main Street Program, are (1) Promotion, (2) Organization, (3) Design and (4) Economic Restructuring.

XIOwn Board of Metropolitan Police Commissioners
The Town Board of Metropolitan Police Commissioners is comprised of a panel of five persons, appointed by the Town Council. They serve for a term of three years and at the pleasure of the appointing authority. No more than three members may be of the same political party.

The fifth member is appointed by the School Board from its membership for a term no longer than the term enjoyed as a school board trustee. The sixth member is appointed by the Board of Directors of the Lake County Library. The department's administrator is a Superintendent of Parks and Recreation who is appointed based upon training or education in the field of parks and recreation. Park and Recreation Board manages the several parks and facilities, hires staff to maintain the parks and to provide recreation programming.

☐ Plan Commission

The Highland Municipal Plan Commission consists of seven members, three of whom are appointed by the Town Council and must be elected or appointed municipal officials or employees in the municipal government, as members. Four members (also called citizen members) are appointed to four-year terms by the Town Council President. No more than two of these members may be of the same political party.

The Plan Commission assists in the administration of the Planning and Zoning Law of the Town and is the body that administers the Unsafe Building Ordinance. The Plan Commission performs its planning and zoning law responsibilities by making recommendations to the legislative body

- (1) The adoption of the comprehensive plan and amendments to the comprehensive plan; (2) The adoption or text amendment of:
- - An initial zoning ordinance;
 - A replacement zoning ordinance; and A subdivision control ordinance.
- (3) The adoption or amendment of a PUD district ordinance as defined in I.C. 36-7-4-1503; and
- (4) Zone map changes.

Advisory Board of Zoning Appeals

Members of a BZA may not hold other elective or appointive office in municipal, county or state government, except as permitted by I.C. 36-74-902. Member must be a resident.

The Advisory Board of Zoning Appeals is comprised of five members, (3) of whom are appointed by the Town Council President, (1) of whom is appointed by the Town Council and (1) of whom is appointed by the Plan Commission. The board of zoning appeals hears and determines appeals from and review:

(1) any order, requirement, decision, or determination made by an administrative official, hearing officer, or staff member under the zoning ordinance;

(2) any order, requirement, decision, or determination made by an administrative board or other body except a plan commission in relation to the enforcement of the zoning ordinance; or (3) any order, requirement, decision, or determination made by an administrative board or other body (except the plan commission) in relation to the enforcement of an ordinance requiring the procurement of an improvement location or occupancy permit.

In addition, the Advisory Board of Zoning Appeals shall approve or deny all:

- (1) special exceptions; (2) special uses;
- (3) contingent uses; and
- (4) conditional uses

from the terms of the zoning ordinance, but only in the classes of cases or in the particular situations specified in the zoning ordinance. The board may impose reasonable conditions as a part of its

Brief Description of Boards and Commissions

☐ Board of Sanitary Commissioners

The board of sanitary commissioners as currently constituted is a five (5) member panel, all of whom are appointed by the municipal executive (The Town Council President by law) for a term of four years, no more than three (3) of whom may be of the same political party. The department's administrator is a Superintendent of Sanitary District, appointed on the basis of his training or fitness to administer the utility to which he is assigned, who is the Public Works Director by virtue of his office.

In addition to managing the sewage works, the board of sanitary commissioners has jurisdiction over a special taxing district referred to as the sanitary district of Highland, which is coterminous with the corporate boundaries of the Municipality. In addition, it is empowered to issue bonds and incur bonded indebtedness not to exceed twelve percent (12%) of the net assessed valuation of the jurisdiction. The Board recommends rates and charges sufficient for the operation and maintenance of the wastewater and storm water utility. The Board manages the storm and sanitary sewer plant of the town.

☐ Board of Waterworks Directors

The water works board of directors as currently constituted is a five (5) member panel, all of whom are appointed by the municipal executive (Town Council President) for a term of one year. No more than two (2) of whom may be of the same political party. The department's administrator is a Superintendent of Waterworks, appointed on the basis of his training or fitness to administer the utility to which he is assigned, who is the Public Works Director by virtue of his office.

In addition to managing the plant of the waterworks utility, the waterworks board of directors has jurisdiction over a special taxing district referred to as the water works district, which is coterminous with the corporate boundaries of the Municipality. In addition, it is empowered to issue special taxing district (g.o.) bonds and incur bonded indebtedness not to exceed eight percent (8%) of the net assessed valuation of the jurisdiction. The Board recommends rates and charges sufficient for the operation and maintenance of the waterworks. In addition, the board is responsible for the delivery of safe drinking water for Highland residents.

☐ Park and Recreation Board

The park and recreation board, as currently constituted, is a six (6) member panel, four of whom are appointed by the <u>legislative body (Town Council)</u> for a term of four (4) years, on the basis of

Board and Commissions Appointment Policy Requirements

Town of Highland December 2019

The Town Council of the Town of Highland believes that it is good public policy to communicate its expectations of candidates for position openings on all Boards and Commissions of the Town. These policy requirements will apply to all appointed positions, whether the appointment vests with the Town Council, the Town Council President or a multiple jurisdiction. Further, positions for service as an appointed officer on a board or commission should be seen as opportunities for service.

A candidate for appointment must file a complete application with the Town Clerk-Treasurer prior to the announced deadline.

Candidates must be available for interviews.

Qualifications for appointment are fixed by law and vary in some cases depending on the board or commission. In most cases, candidates must reside within the municipal boundaries of the Town of Highland. When statutory provisions are silent regarding residency, it is still preferred unless the appointment is shared with other jurisdictions or is regional in nature. The candidate in the form of driver's license, voter registration record, or other acceptable documentation must validate residency.

Candidate voting records may be reviewed at the Lake County Voter Registration Board. In some cases, party affiliation must be considered for appointment, due to Indiana law. A letter from the chairman of the county party of your expressed affiliation may be necessary if voter records cannot determine party affiliation. Again, this would only be necessary if party affiliation is a statutory requirement for the board/commission position you may be seeking.

Ms. Miller of 9013 Cottage Grove Avenue, offered a brief narrative regarding her resume and work background. She said she has lived in Highland roughly 35 years. She along with her husband Gary, owned Prompt Ambulance Service from 1998 until 2017. She said she is retired, not doing much but her husband Gary is still working with EMS on the state level. She said she knows a little bit about police departments as her brother was the police chief in Michigan. She said that after they sold the ambulance business she did other work outside of Prompt but mainly concentrated in divesting all of the property. She estimated it took her 2 to 3 years. She was very instrumental in that.

Ms. Miller responded to questions regarding his interest in the Metropolitan Police Commission.

Councilor Turich asked Ms.. Miller what kind of strategies she would like to see implemented particularly if selected to enhance community relations in our Town? Additionally, how would she measure the success of those initiatives?

Ms. Miller said she wasn't sure how she would implement policies to do that but certainly she would be looking for public feedback to establish and implement policies.

Councilor Turich then asked Ms. Miller if she had any ideas or opportunities that she has identified or her vision of the current Police Commission?

Ms. Miller said she didn't know too much about the actual workings of the police department so it is hard to have a vision or ideas of what you want to change if you're not fully aware of their activities but should she be selected and become more involved, she would have better ideas.

Councilor Turich then asked from a resident's perspective, is there any opportunities that she recognized within the community that she would like to see improved?

Ms. Miller responded that she thought the public has a pretty good opinion of our police department. She said she watched on Facebook pages where people would bring donuts and things like that. She said that is a nice thing and it shows support for the police department from the public.

Councilor Scheeringa asked if she knew any of the current officers?

Ms. Miller she didn't. She knew some from the days when she was involved with Prompt but not now. She said she knew John Siple and Mike O'Donnell but they're both retired.

Councilor Turich asked Ms. Miller what interested you in this role? What drove you to pursue it?

Ms. Miller said because she isn't doing anything right now and she thought it'd be kind of fun to have something to be involved in. Being a Highland resident for half of her life, she wanted to be a part of something that does something for the community. She had the same feeling when she worked at Prompt. Whereas, she didn't actually go on calls, she had the opportunity to do something for the community.

Councilor Black asked Ms. Miller what was the biggest asset she could bring to the commission and if you are not selected, would you still be interested in serving on any other boards or commissions?

Ms. Miller said if she was not selected, she would definitely be interested in serving on another board or commission. She added, with the police department and having owned a business and been involved in EMS, she thought that would be a good fit as she had a pretty good idea from the employees point and then the management point and trying to bring the two together. She said she did some fund-raising for the Legacy Foundation and a little bit of fundraising for the Humane Society. She said she read a little bit of a controversy about a building or something and they talked about having it for the new animal control shelter.

Councilor Georgeff said it doesn't look like that building is going to work out for us there. He said they have entered into discussion in Munster regarding a joint venture. He added that one of the objectives of the Police Commission and Department is to come up with policies to keep our officers living in Town. He mentioned the offering of the monthly stipend.

Ms. Miller said she agrees with that because if you don't live in Town, say you live in St. John, where is your sense of community. She really didn't have anything else to add as she didn't sit through a Police Commission Meeting.

The Town Council President thanked Ms. Miller for attending.
