- New LED Light Engineering Streets Redevelopment asked to pay for engineering. We must decide if we want the entire project engineered all at once or in segments. Redevelopment asked to pay for the project work as well. This will allow public works to put more funds into traffic signals and reduce the need for maintenance on the existing streetlights. NEIS has a proposal which was paid for by public works. The price may not be currently valid. A new proposal may be necessary. Safe streets will not pay for engineering, but we can apply for a grant to assist with installation of the LED upgrade.
