 - x. Discussion: Summary of Revenue Impact:

Based on the 2nd reading amendment, the Town of Highland will receive less revenue over the next three years: (Civil Town only, not inclusive of Sanitary or Water)

- 2026: \$748,600 less (not inclusive of circuit breaker loss 2024 it was \$508,531.58
- 2027: \$783,960 less (not inclusive of circuit breaker loss –
- 2028: \$1,559,780 less (not inclusive of circuit breaker loss –

Budget Reduction Estimate:

The General Assembly estimates a total reduction to the Town of Highland of \$3,092,340 over the next three years due to SB1. To address this, the Town should consider:

- 1. **Raising Revenue:** Explore alternative sources like Wheel Tax, Trash Fees, Other Fees, Income Taxes, etc.
- 2. Adjusting Services: Identify services that can be modified, reduced, or discontinued.

In reality, SB1 is roughly 370 pages, I don't think anyone has totally grasped the impact

Use the 2025 budget as a baseline to evaluate these solutions. Likely, a combination of approaches will be necessary.

Highland residents face a double jeopardy on taxes like the wheel or local income. If the county was to pass a wheel tax, in addition to the local income and the Council passes the same, Highland residents would be double taxed.

Any additional debt, created by any taxing units (school town referendum, library board, county etc.) will most likely trip the circuit breaker for many residents, meaning less revenue for the Town.

- x. Discussion: The May 26, 2025 Town Council Plenary Meeting and Study Session fall on Memorial Day. Does the Council want to meet? Cancel? Reschedule? In 2024, the Council cancelled the Monday, Memorial Day meeting and rescheduled it for the next day on Tuesday.
- **x. Discussion:** Lamar Advertising Non-Binding Letter of Intent to purchase easement. Currently, Lamar pays the Town of Highland, \$40,000 annually. Lamar is proposing to pay a one-time, lump sum of \$450,000 to purchase the easement.

x. Discussion: Revisiting plans about a new town hall

Councilors Turich and Robertson to tour existing sites (both internally and externally) to determine if another suitable site could be found to accommodate the head count in the town hall during the construction of a new town hall or during retrofitting the existing town hall or eliminating the need to do neither and permanently locate the head count into a different facility. Inclusive should be any external costs such as rent, utilities and other miscellaneous costs and loss of revenue if a town owned facility is used. A determination of the head count that could be relocated.

x. Discussion: Restructuring the Police Commission

Police Commission Liaison Scheeringa to meet with FOP President Glidewell and then report back to the Council on subjects that need the attention of the Council.

x. Discussion: Attorney Reed to meet with the Clerk-Treasurer to draft a middle ground proposal to present to the Council on how to comply with the new state law regarding parking over a sidewalk and exempt those with driveways that are too short to allow the homeowner to be in compliance. Some driveways in the older section of Highland won't accommodate one car.
